Once you have completed your registration to Quickfisco, you will receive **two different e-mails**:

1) One to confirm your account, which must be done within 48h (otherwise it'll be automatically deleted and we won't be able to activate your subscription and to allow you using out webapp.

2) A second e-mail from a-cube/e-witness: it's a service which guarantees the proper conservation for electronic invoices. In this case you will just have to log in the first time and save the details (username and password).
